# **Anti-Discrimination and Inclusivity Policy**

# **Kelowna Riding Club**

The Kelowna Riding Club (KRC) is committed to fostering an environment of inclusivity, respect, and equality. We believe that every individual, regardless of background, should feel welcomed and valued. This policy outlines our commitment to anti-discrimination and inclusivity within our club community.

## 1. Commitment to Inclusivity

- Gender Identity and Expression

## 2. Zero Tolerance for Discrimination

The KRC strictly prohibits any form of discrimination, harassment, or exclusion based on race, gender, sexual orientation, religion, disability, or any other protected characteristic. This includes:

- Discriminatory language or behavior
- Harassment or bullying, whether verbal, physical, or online
